Jose Diaz, Candidate for County Legislator -17th District-In His Own Words

One of the contested races in Yonkers on November 7 will be for Westchester Legislator in District 17, which includes most of Southwest Yonkers. Democrat Legislator Jose Alvarado is being challenged by republican Jose Diaz.

This heavily democratic district usually does not have a republican opponent, but Diaz is running an active campaign. We asked Diaz to write about his campaign and why he is running.

"I am an American of Dominican origin, having become a United States citizen in 1996. I attended Mercy College for a period of almost four years, studying Computer science and programming languages. I also attended Westchester Community College, taking electronics and robotics classes. I made the decision to leave college to help my family financially.

"I have lived in Yonkers most of my life and I love the city I made my home for so many years. My decision to run for the office of Westchester County Legislator was due to my concerns with so many serious worsening problems in the 17th District.

"The 17th District has been inundated with illegal weapons and more control and interception of these illegal weapons are desperately needed. On April 20, 2022 a Yonkers police detective was shot, an incident that took place in the vicinity of Elm and Linden Streets. This detective suffered extensive internal injuries and almost died.

"The months of July and August of this year have seen an increase in shootings, stabbings and residential break-ins and burglaries. The problem of drug dealing has also increased significantly. We have a crisis with the selling and use of fentanyl, a very addictive and dangerous drug; we see drug addicts committing crimes to support their addiction, with many resorting to prostitution, becoming increasingly visible in the community. Many of those addicted can also be seen injecting their drugs openly in public places. It is demoralizing to the community overall and a significant public health issue.

"Yonkers has its own problem with active gangs, made worst by gang members from other municipalities and other areas. These gang members come to our city to start their initiation rituals and killings.

"There is an increase in homelessness in certain neighborhoods in this district, creating a health problem. There are often individuals blocking sidewalks, consuming alcohol in public areas, and defecating and urinating in public places.

At a time when we see instability in the world, and dysfunction in Washington DC and in Albany, it's clear that in Yonkers, Mayor Mike Spano has been able to work with all Yonkers residents to move New York's 3rd largest City forward.

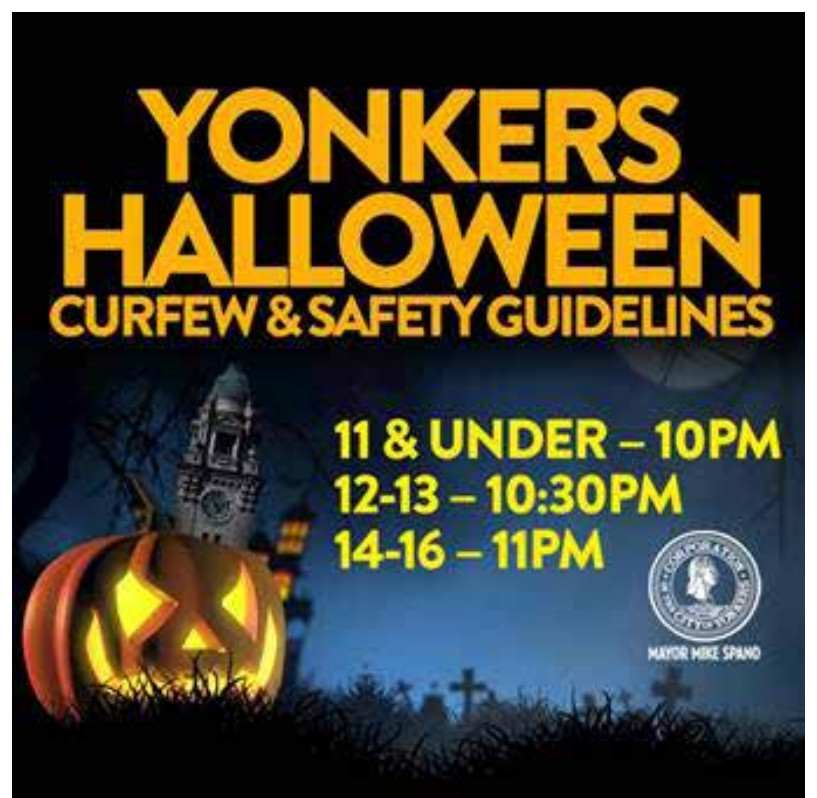
Mayor Spano has also kept his budgets under the tax cap for 11 of 12 years. The financial condition of the City is the best it has been in many years.

CSEE Artisans' Fair Commemorates Hispanic Heritage Month

Local artists celebrated the creativity of the Puerto Rican community at the Charter School of Educational Excellence's fall Artisans' Fair.

Thirteen artisans from the Puerto Rican Institute for the Development of the Arts (PRIDA) displayed their creations at the school on Oct. 7 and they shared stories about their inspiration with the public.

"We asked PRIDA's members to participate in an artisan's fair because their mission is to promote and preserve folkloric traditions. One of the Charter School of Educational Excellence's goals is developing the whole child. That means giving our students exposure to traditions and expressions that are relevant to their cultures so that they feel inspired to learn and create," said Carmen Goldberg, the CSEE's director of government, parents and external relations.

The Artisans' Fair included performances by Puerto Rican Cuatro Player Luisito Rodriguez and his Cuatro Band along with dance presentations from Additude Cultural Arts Center, the Mexican Cultural Committee, and the Dominican Cultural Association of Yonkers.

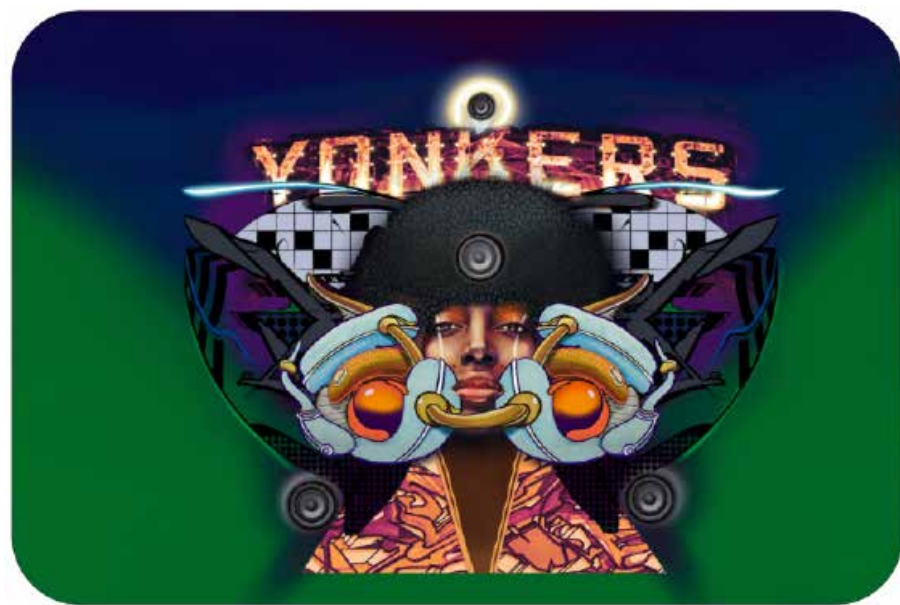
The event was part of the Charter School of Educational Excellence's continuing investment in the arts.

In May the school inaugurated a new stage at its high school designed to help students learn theatrical rigging and other skills that will help them land jobs at Lionsgate Studios and other media stages opening in Yonkers. The new stage includes state-of-the-art audio-visual capacities and a large projection screen.

PRIDA grew out of an annual Puerto Rican Artisan Fair in New York City that is the largest such fair outside of Puerto Rico. The group's goals include opening new markets for Puerto Rican artists, promoting culture and advocating for arts funding.

Yonkers Public Library Releases Limited Edition Library Card, Celebrates 50 Years of Hip Hop

On Thurs., Oct. 26, Yonkers Public Library (YPL) will release a limited edition library card in recognition of the 50th anniversary of hip hop. The card features art by Yonkers native and acclaimed street artist Daniel Hopkins (AKA Maxx Moses or Pose2) and will be available at all library locations.

The unveiling will be followed by a panel discussion with hip hop legends, including Ruff Ryder Founder Joaquin "Waah" Dean, Yonkers hip hop artist Large Amount, and Jerome "RawRome" Enders, author of Yonkers: The Lost City of Hip Hop.

"YPL recognizes hip hop to be a vital artform and an essential part of Yonkers culture and history. We're excited to celebrate its 50th anniversary with a fresh new library card designed by one of Yonkers' own and that reflects its energy and creativity," said Jesse Montero, library director.

The special edition card is titled The Sound of Light and features imagery that is both futuristic yet grounded in the soulful roots in which hip-hop was founded upon. The patterns in the background and on the clothing are all derived from graffiti.

All Yonkers residents can request the special edition card when they apply for one at YPL.org while supplies last. All current cardholders can trade in their current card for a new card by visiting any of YPL's three locations.

"As an artist, I'm always desiring to create imagery that shows Black Culture thriving in the future while staying connected to art, science and nature, with style," said Moses. "This design for the library celebrates the next 50 years of hip hop, with an energy that's rooted in a culture Boombastic by nature and guided by the divine mind."

In partnership with Enders and Harold McKoy, CEO of Executive Branch Entertainment Group, the limited edition card is part of a larger series that highlights the role Yonkers played in helping to develop the culture and music of hip hop. Enders will moderate the panel discussion while intermittently reading excerpts from his book Yonkers: The Lost City of Hip Hop. Copies will be available to check out at the library and available for purchase at the event.

"The role of Yonkers hip-hop is intrinsically tied to its roots, as the early pioneers of Yonkers ventured back and forth to the Bronx, disseminating the culture within our city. Furthermore, our venues became a hub not only for local talent but also for practitioners from various places, who came to Yonkers to

Mayor Spano Asks Students at School 9 to Sign Pledge 182

In an effort to improve academic readiness, Yonkers Mayor Mike Spano and Yonkers Public Schools held an assembly at School 9 and asked Yonkers students to participate in the Pledge 182 campaign, in which students commit to attend school every day and on time.

“Education is the cornerstone of our future, and every day missed in school is a missed opportunity for growth,” said Mayor Spano. “In Yonkers, we believe in nurturing the potential of every child. Regular school attendance is not just a legal requirement; it’s a chance for our children to learn, explore, and prepare for a prosperous future. Collectively, let’s ensure every child in Yonkers has the opportunity to succeed by prioritizing school attendance.”

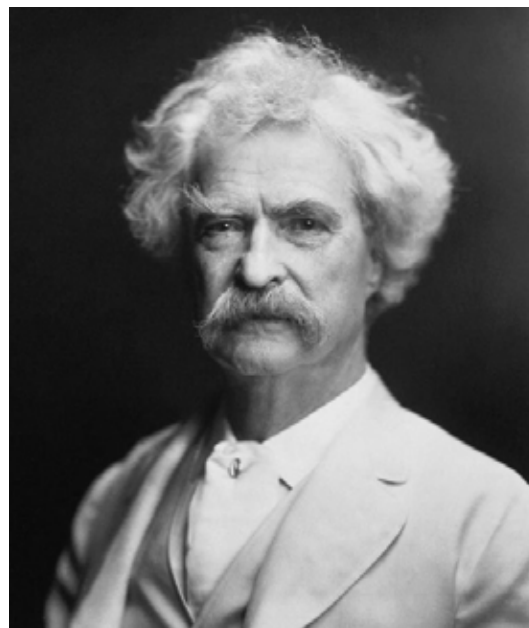
Research has shown that students who miss 10% of the school year (18 days or 2 days per month) are not as academically successful through their school years and have a more difficult time graduating. Starting as early as Kindergarten, chronic absenteeism can cause a student to fall behind in school. In fact, chronic absenteeism, missing 18 days or more, can make it more difficult for children to learn to read and develop fundamental math skills.

“The Mayor’s Pledge 182 Campaign has been a big success in the Yonkers Public Schools. For example, last year the Mayor called on the students of the Martin Luther King, Jr. Academy to increase their attendance rate, and they did. In just one year, the data showed that the attendance rate increased to 90%,” noted Interim Superintendent of Schools Dr. Luis Rodriguez. “I believe it is incredibly important for our students to make the connection between attendance, social and emotional success, and academic achievement in the classroom. I am grateful for the Mayor’s efforts on this initiative. I am looking forward to celebrating with the students of School 9 in June, when they too meet and hopefully exceed the Mayor’s challenge.”

Mayor Spano challenged the students of School 9, urging them to sign the pledge and promised to return in June and give a pizza party to the students who achieve a perfect attendance during the 2023-2024 academic school year.

On This Day in Yonkers History...



Mark Twain lived in Yonkers for a year

Monday, October 30th

October 30, 1919: The Knights of Columbus held a benefit dance at St. Mary’s for their proposed veterans’ home; noted song writer Victor Nurnberg introduced several of his latest hits, sung by New York City singers A. Mac Alanen and Ralph Conlon. Parishioners of Sacred Heart held a benefit at the Chippewa Club to support the effort; these two events brought the total of pledges to \$76,000.

October 30, 1943: Clifferest at 523 Riverdale Avenue, once rented by Mark Twain and his family for a year, was formally dedicated as a home for seamen of the United Nations. The new unit, run by the Manhattan unit of the American Women’s Hospitals Reserve Corps (AWHRC), was named the Gloryhole. The historic house was converted into a modern country home to provide rest and recreation for seamen on sick leave or furlough. Major Rosalind Cowen, Director of the AWHRC, officiated at the ceremony; William Ruxton, former president of the British-American Ambulance Corps, was master of ceremonies.

Tuesday, October 31st

October 31, 1912: Mrs. Corinne Knickerbocker presented a life-size bust of George Washington to Mayor Lennon for the City of Yonkers. Created by the late Wilson MacDonald, it was a replica of Houdon’s life mask of Washington, molded directly from Washington’s face in 1785. MacDonald made many castings of this bust, numbered them and wrote on the back, “This is a mathematical reduction of the original Life Mask Bust of Washington, sworn to by Wilson MacDonald, Copyright 1899, The Menry-Bonnard Bronze Co, Founders NY 1899.”

October 31, 1935: An earthquake that shook 17 states and Eastern Canada hit Yonkers. Although no real damage resulted from the quivers felt in Yonkers, thousands jumped out of bed in panic.

October 31, 1945: A bit of role playing by a victim led to a bandit incriminating

Nick Sperenza is the republican candidate for City Court. We were recently sent information about Sperenza concerning an election lawsuit filed against him when he was collecting signatures attempting to get on the democratic party line for Judge this year, The court transcript reads that both Judge Doran and Judge Beltran, "my clients (Doran and Beltran) were very concerned about making a fraud allegation against a person who's running for Judge and who's an attorney. And for all of the consequences that could happen and they were hesitant to do that, except that the evidence was so compelling. There's the video evidence.

Tanika Smith submitted an affidavit, "she was asked by Nick Sperenza if she was a Democrat and if she would sign the petition and she knew Karen Beltran. Karen Beltran came to her wedding. They have family friends. They have children the same age and they know each other. And she'll testify that she told Mr. Sperenza, well, I know Karen and she's running for Judge, some kind of Judge, and she will testify and it's in her affidavit that Mr. Sperenza said to her, oh, well I'm running with Karen Beltran and you can vote for us both. And he also said that he was a democrat in that conversation."

Sperenza testified that he was a democrat for the last three elections and then changed registration to a republican this year.

We endorse Judge Karen Beltran and Judge Arthur Doran for Yonkers City Court. Early voting starts on Oct. 28 and Election Day in Nov. 7.

PUBLIC NOTICE

A Local Law amending Chapter 85 entitled, "Forfeiture of Vehicles in Connection With Criminal Acts" in relation to forfeiture of vehicles attempting to evade police officers.

Notice is hereby given that the City Council of the City of Yonkers has adopted the abovementioned legislation that provides a means for the City to seize and subsequently seek the forfeiture of vehicles used in the attempt to flee/evade police officers to reduce and eliminate the occurrences of high-speed chases or dangers involving police chases within the City of Yonkers.

The penalties for offenses pursuant to this ordinance are as follows:

A civil action seeking forfeiture brought pursuant to this section shall be commenced in the County of Westchester within sixty (60) days after such person has been convicted of any offense arising out of his or her arrest or summons under section eleven hundred eighty-two of the Vehicle and Traffic Law, if brought pursuant to subsection A. of this section, or within sixty (60) days after such person has been convicted of any offense arising out of his or her arrest or summons under sections 270.25, 270.30, or 270.35 of the Penal Law, if brought pursuant to subsection B. of this section. The Yonkers Police Department shall make a timely notification to the Office of the Corporation Counsel regarding such conviction, or other disposition of the applicable criminal action or proceeding regarding such person.

The complete text of the ordinance is on file and may be examined at the Office of the City Clerk, City Hall, 40 S. Broadway, Yonkers, NY 10701.

Dear Friends and Neighbors,

Once again, I am asking for your vote!

I served on the Westchester County Board from 2020 to 2022, during the worst global pandemic in a century. I'm past Board member of Groundwork Hudson Valley as well as former Court Clerk in the Bronxville Justice Court, former President of the Bronxville Library Board of Trustees and former PTA member.

YONKERS MAN SENTENCED TO 9 YEARS FOR DRUG TRAFFICKING

Philadelphia to Yonkers Cocaine Route Closed; 3 Kilos and \$300k Cash Found Stashed in Yonkers Apartment

Westchester County District Attorney Miriam E. Rocah announced prison sentences for three defendants convicted of illegal narcotics possession and interstate drug trafficking, with an additional sentence for one of the defendants who investigators discovered had videos and images of children engaged in sexual acts on his cell phone.

DA Rocah said: "The successful prosecution of these cases reflect our strong commitment to removing drug traffickers from our communities and securing a sense of safety in our neighborhoods. This is a result of yet another strong partnership with our federal, state and local law enforcement on cracking down on the flow of illegal narcotics from out of state, and also the intra-office collaboration between investigations and cybercrimes to identify someone who also posed a threat to children."

A six-month multi-agency investigation that began in February 2022 focused on the illegal possession and trafficking of cocaine from Philadelphia to Yonkers between the three defendants. The High Technology Crimes Squad of the DA's Office conducted a forensic analysis of the defendants' cell phones and discovered text message photos of drug sales, including images of cash and cocaine worth more than \$1 million, which demonstrated the role of the defendants in this crime.

Christian Miranda, 34 of Yonkers, was sentenced on June 5 before Judge James McCarty to nine years in state prison, with five years of post-release supervision, after pleading guilty to Operating as a Major Trafficker and Criminal Possession of a Controlled Substance in the First Degree. The defendant was arrested on Aug. 2, 2022, along with Rivera, by the DEA's New York Drug Enforcement Task Force (DETF-13), which recovered three kilograms of cocaine and more than \$300,000 hidden in furniture at their Yonkers apartment.

Marco Rivera, 31 of Philadelphia, was sentenced on Sept. 28 before Judge Robert Neary to 12 years in state prison, with five years of post-release supervision. Following a three-week trial, a jury on May 11 found the defendant guilty of Criminal Possession of a Controlled Substance in the First Degree and Criminal Possession of a Controlled Substance in the Third Degree.

In addition to his drug conviction and sentence, the defendant was also sentenced on Oct. 19 before Judge Susan Cacace to an indeterminate term of 1 1/3 to four years in state prison for his guilty plea to three counts of Possessing an Obscene Sexual Performance by a Child. This follows a 57-count indictment by a Westchester County Grand Jury in March for Possessing an Obscene Sexual Performance by a Child stemming from DA's Office forensic investigators discovering multiple videos and files of children engaged in sexual acts on the defendant's cell phone. The court decided both sentences will run concurrently.

Mark Figueroa, 61 of Brooklyn, was sentenced on June 8 before Judge McCarty to six years in state prison, with two years of post-release supervision, after pleading guilty to Criminal Possession of a Controlled Substance in the Third Degree. DETF-13 arrested the defendant and recovered an additional four kilograms of cocaine inside his car following a drug exchange with Miranda on Nepperhan Street in Yonkers.

you run into our Officers, say hello! Don't hesitate to approach any of our Officers in the event that you need any kind of assistance. We, as always, are here to help."

As part of the curfew, the Yonkers Police Department advises:

- Children ages 11 and younger must be home by 10PM
- Children ages 12 to 13 must be home by 10:30PM
- Children ages 14 to 16 must be home by 11PM

Exceptions include:

- Accompanied by parent or guardian.
- On an errand with parental permission, with prior notice to YPD Community Affairs Division – 914-377-7293
- ½ hour after the end of school, religious and volunteer public entertainment -- no later than 12:30AM unless police are notified by host organization 24 hours in advance
- ½ hour after work -- with proof from Employee
- All youngsters 16 and under not subject to curfew if on or immediately next to their home (and if neighbor does not object)

Violators of the curfew will be taken to the nearest Yonkers Police Precinct, and parent/guardian will be notified. For more information about the Halloween curfew, contact the Yonkers Police Department at 914-377-7293.

Following are Halloween safety tips issued by the City of Yonkers for parents, children & residents:

- Parents
- Do not leave children unattended.
 - Know the route your child will travel and give him or her curfew.

Salvation Army Yonkers Citadel Corps Holds Annual Dinner at Dunwoodie County Club

The keynote speaker for the evening was Mark Fang, executive director of the City of Yonkers Commission on Human Rights and a former Director of the Westchester County Department of Consumer Protection and the County's Human Rights Commission. Fang, a veteran and Lieutenant Colonel in the United States Army Reserves, praised the faith-based work of the Salvation Army and likened his years as an Army reservist to the work of the Salvation Army corps: "I have loved being a soldier in the Reserves for basically my whole adult life, and I bet you as well love being soldiers. As the Reservist is a Citizen-Soldier, you are all Christian-Soldiers, Fang said." In his speech, Fang reflected on the March 2021 hate crime attack in which an elderly Asian woman was badly beaten in the vestibule of her Riverdale Avenue apartment building by Tamil Esco, who called the woman an "Asian Bitch," in the course of his relentless and brutal assault of her. Esco later entered a plea of guilty to assault as a hate crime and sentenced to a term of imprisonment of 17 years, for which Fang praised Westchester County District Attorney Mimi Rocah for bringing justice to Esco that was "swift and certain." Fang closed with a poignant and thought provoking reflection on hate crimes and, more basically, the nature of hate:

The bail reform changes only worsened the effects of the serious crimes in the 17th District.

There are still problems with odors emanating from the Yonkers waste water and sewage plant. The odors released by the plant contain airborne bacteria and germs, which can affect people with compromised immune systems. Many of the residents still complain despite the millions of dollars spent to mitigate the problem.

The people of the city of Yonkers want change. The current legislator forgot that he is a public official accountable to the people he represents, not to the status quo. More than a decade ago it was reported that Jose Alvarado was appointed to the position of Yonkers City Clerk, apparently neglecting to inform City Hall that he already had a full-time job in the private sector. He also apparently used the city vehicle assigned to him to commute to his OTHER full-time job. It is time for change. I will be the representative the people of the 17th District deserve," writes Diaz.

"What really sticks out most in my mind about this hate crime attack was what Mayor Mike Spano said on the steps of City Hall at news conference with the Philippine Consul and other community leaders. What he said was something very profound, and clearly from the heart. What he said was to the effect of: "We can put more police on the streets; we can have special patrols; we can put up cameras; etc., but we can't change what's here (pointing to his heart). We can't change the heart." But what was the Mayor saying? What did he mean? What he was saying is that when it comes to hate and racism, of course law enforcement and bringing offenders to justice is important, but as a society it can only take us so far. We need to go beyond this.

We need to build a society based on love, charity, grace, our common humanity, and if I dare say—on Faith. All of the things, cornerstone principles of the Salvation Army. Our world is obviously broken. We need to double down on our Faith, on the principles that have made the Salvation Army such an enduring organization, we need you more than ever."

Wednesday, November 1st

November 1, 1899: The November Argosy featured the opening chapters of "The American Syndicate," a novel by Frederick Burton of Yonkers. The story tells the experiences of a New Yorker who heads to Puerto Rico with \$33 in his pocket and a signboard to undertake big business schemes.

The hours for Yonkers Target are Sunday through Monday, from 8 a.m. to 10 p.m. A 40-year lease agreement with Marx Realty is good news for the retail industry and good news for Yonkers, with 290 jobs created with this newest Target in Westchester.

November 1, 1913: The Yonkers Camera Club opened its new clubrooms in the Hollywood Inn, fully equipped with a dark room and other photographic facilities.

November 1, 1929: Overcome by her admiration for Alvin "Shipwreck" Kelly's pluck, a twenty-two-year-old telephone operator prevailed upon the flagpole sitter's attendants to hoist her up to his side on top of the Proctor Building and rewarded him with a kiss, while the crowd below cheered.

Thursday, November 2nd

November 2, 1925: Yonkers offered to settle a tax lien of \$36,991 for \$17,000 plus arrears of taxes on the William Boyce Thompson Institute of Plant Research.

November 2, 1927: Fire destroyed one of the few remaining farmhouses in Yonkers. The fire left the house at 77 Mile Square Road in ruins; the only animal on the farm was rescued, a cow owned by Louis Tishkowitz.

Friday, November 3rd

November 3, 1919: The total collected for the K of C Memorial Hut Drive for wounded veterans rose to more than \$81,000; the campaign was halted until November 11th, so the drive would not compete with the Red Cross Roll Call for membership.

November 2, 1926: Yonkers voters indicated by a ratio of five-to-one they favored modification of the Prohibition Amendment. 15,499 voted in favor of change, while 3,630 voted against it.

Martinez is a Yonkers resident who grew up coming to the Cross County Center all of the time. He has decided to raise a family and stay in Yonkers.

November 3, 1935: More than half of the 60,000 registered Yonkers voters had cast their ballot by noon.

Saturday, November 4th

November 4, 1944: City Manager William Walsh refused to resign his position; three council members—Mayor Curtiss Frank and Councilmembers Edith Welty and John Whalen—had offered him the choice of resigning or face termination for what they called his lack of "energetic approach to municipal budgets." Walsh told them they should, "Take the usual procedure, as I want to tell the whole world about this, and I certainly intend to do so."

Sunday, November 5th

November 5, 1923: Yonkers Communists ran their red flag and banner over our City Hall in the dead of night; their banner commanded "Cash relief. Vote Communist!"

November 5, 1936: Justice William F. Bleakley of Yonkers suffered a defeat in his run for governor as a record shattering New York vote for President Roosevelt swept Governor Herbert Lehman back into office.
